Minutes of Pre-Bid Meeting towards the Tender for Uniform for Cadets at IMU-KC

The Pre-Bid meeting towards the Tender for Uniform for Cadets at IMU-KC was held on 19.06.2017 at the Conference Hall of IMU-KC. Representatives of 4 nos. Firms and the officers of IMU-KC participated in Pre-Bid Meeting.

Representatives of the following Firms were present:

The following points were discussed in the meeting:

- Representative of M/s. Status collection asked whether it is mandatory to quote price of all items in a Package. It was confirmed that it is mandatory as per the terms and conditions of the Tender.
- 2. Representative of M/s. Status collection further clarified whether the rates would be valid for a period of 1 year or it may be extended. It was clarified that as per the condition of the Tender the contract would be valid for a period of 1 year initially and can be extended based on satisfactory performance.
- 3. Representative of M/s. Rimi's Creation asked whether measurement has to taken for Sports Uniform or they will be of standard size and whether they will have to deliver the items in packets. It was replied that measurements have to be taken and delivered in packets that will be visible from outside by putting the registration no. of the Cadets.
- 4. Representative of M/s. Asian Garments had asked whether the time for the delivery of the uniform items will be extended. It was clarified that as per the condition of the Tender, measurements have to be taken from the Cadets within 7 days of placing Order and delivery have to be made within 45 days after taking measurement. No extension of time will be given after such period for delivery of the uniform items.
- Representative of M/s. Status collection asked whether individual orders would be counted towards eligibility criteria. It was stated that only institutional/official orders would be considered and not individual orders.

6. Representative of M/s. Monsons asked about the impact on the rates if GST is applicable from 1st July, 2017. It was clarified by DFO, IMU-KC that if GST is applicable from 1st July, 2017, then such rates will be applicable. It was further stated that the Suppliers can quote the base rate of the items and indicate the prevailing Tax rate separately when they will quote the price of the items. However, if GST is applicable then that rate will be added to the items. If higher tax rate is stated in GST, IMU-KC will pay that rate. On the other hand, if lower tax rate is stated in the GST, then the benefit of the lower tax rate has to be passed on to IMU-KC by the Suppliers. A corrigendum will be given in the website regarding the Format of the Price Bid where the base rate and the tax part will be shown separately. The Suppliers can quote as per the new format.

The meeting ended with a vote of thanks.
